## SCOPE OF ADDENDUM #2 - February 14, 2023

The following items constitutes the Town's response to questions presented by one of the potential companies submitting a bid. These items must be considered and addressed within submitted bids. Bid submissions not incorporating these addenda will be subject to rejection.

Revision 2: Section III: Scope of Work, § D: the total length of the project is estimated at 365 linear feet. The constructed sidewalk will be 5 feet wide (60 inches); with the addition of a patio, near the concession stand measuring 10ft x 10ft cement pad. The lump sum amounts submitted will be for this area.

<u>Revision 3:</u> In addition, submissions <u>must</u> include a per unit cost per linear foot. This may be indicated on Page 2 of the Proposal Submission Form.

Revision 4: Installed concrete will be between 3,000 psi and 3,500 psi.

<u>Revision 5:</u> Expansion joints will be no further than 12 feet apart.

<u>Revision 6:</u> Fill dirt will be sidewalk level for the first 18 inches on either side of the newly constructed sidewalk. The dirt may then taper off and be worked into the existing topography.

Revision 7: Section III: Scope of Work, § M: section will be removed.

Revision 8: The accompanying *Proposal Submission Form* must be used in place of the document advertised with the RFP package.
