# Town of Williamsport Mayor & Town Council Work Session June 5, 2023

On June 5, 2023, the Mayor & Town Council for the Town of Williamsport held a Work Session; the meeting was called to order at 7:28pm by Mayor Green.

The Town Attorney outlined the proposal to enact an Urban Renewal Authority to either have the Mayor & Town Council to establish a commission to act in an advisory commission with the Mayor 7 Town Council to have decision making authority or the Mayor & Town Council to act in that capacity solely. The Urban Renewal Authority would make determination to take possession of properties through eminent domain for the purpose of improving the property and reselling it. The property at 40-42 North Conococheague Street was used as an example of a property which has a landowner not willing to invest in their property to improve it. The town could take possession of the property and seek ways to improve the property as owners or sellers. The Town Attorney is seeking permission from the Mayor & Town Council to move forward to establish an Urban Renewal Authority and begin to identify properties that may need to be addressed.

The Town Manager outlined the purpose and intent of Ordinance 2023-03 Illicit Discharge Detection & Elimination and Stormwater Connection Ordinance. The item will be on the agenda for the June Regular Session.

Councilman Tinsley motioned to adjourn which was seconded by Councilman Braswell; the meeting adjourned at 7:47pm.


